



Cathedral Church of All Saints, Halifax Privacy Policy

Purpose:

This policy is to safeguard personal information entrusted to Cathedral Church of All Saints and to comply with the requirements of the Personal Information Protection and Electronic Documents Act (PIPEDA) and any other applicable legislation.

Privacy Principles:

The Cathedral Church of All Saints is committed to maintaining the accuracy, confidentiality and security of all personal information in its possession. The Church, its Council members, Wardens, employees, and volunteers are required to comply with this policy. As part of this commitment the Cathedral Church of All Saints has adopted the following ten principles, based on the values set by the Canadian Standards Association's Model Code for the Protection of Personal Information and Canada's Personal Information Protection and Electronic Documents Act.

1. Accountability

The Cathedral Church of All Saints has appointed a Privacy Administrator who is responsible for the organization's compliance with this policy. Each Council and Committee member, Warden, employee, and volunteer is responsible for maintaining and protecting the personal information under its control and is accountable, for such information, to the Privacy Administrator.

2. Identifying purposes

The Cathedral Church of All Saints collects and uses personal information about individuals solely for the following purposes:

- a. To enable communication;
- b. To provide income tax receipts; and,
- c. To meet statutory and regulatory requirements.

Business contact information and certain publicly available information, such as names, addresses and telephone numbers as published in telephone directories, are not considered personal information.

The only circumstance under which personal information may be disclosed to third parties (such as the Cathedral Church's email news platform Constant Contact) is for the fulfillment of any purposes identified above, or as required by law. Where personal information is disclosed to third parties for the fulfillment of any purposes identified above, the church will make all

reasonable efforts to ensure that the third party has appropriate security procedures in place for the protection of the personal information being transferred.

3. Consent

Unless we hear otherwise, provision of personal information on official church forms and/or through emailed consent, constitutes consent for the Church to collect, use and disclose personal information for the purposes stated in this policy.

An individual may refuse or withdraw consent at any time, subject to legal and contractual restrictions and reasonable notice. The choice to provide us with personal information is always the individual's. Decisions to withhold particular information may impact one's ability to meet specific requirements for the provision of certain services.

An individual may refuse or withdraw consent by contacting the Privacy Administrator by calling (902) 423-6002 or emailing cathedralchurch@eastlink.ca can access this information. The Privacy Administrator will explain the options and any consequences of refusing or withdrawing consent and will record the individual's choice.

4. Limiting collection

The personal information the Cathedral Church collects shall be limited only to that which is necessary for the purposes identified.

5. Limiting use, disclosure, and retention

Personal information the Cathedral Church collects shall not be used or disclosed for purposes other than those for which it was collected, except with the consent of the individual or as required by the law. Personal information shall be retained only as long as necessary for fulfilment of those purposes.

6. Accuracy

The Cathedral Church of All Saints will make all reasonable efforts to ensure that personal information is as accurate, complete, and current as required for the purposes for which it was collected. If an individual finds any inaccuracies in our information, they should inform the Privacy Administrator and we will make the appropriate corrections promptly. In some cases, the Cathedral Church relies on the individual to ensure that certain information, such as mailing address, email address, and telephone number, is current, complete, and accurate.

7. Safeguards

The Cathedral Church of All Saints uses appropriate security safeguards to protect personal information from risks such as loss, misuse, unauthorized access, disclosure, or alteration. Safeguards include physical, administrative, and electronic security measures.

All employees and volunteers of the Cathedral Church are required to abide by the privacy standards we have established. They are also required to work within the principles of ethical behaviour and must follow applicable laws and regulations. During daily operations, access to personal information is restricted to those employees and volunteers whose job responsibilities require them to access it.

8. Openness

The Cathedral Church of All Saints will provide information to individuals about our policies and procedures relating to the overall management of personal information that is under our control or regarding specific personal information about which an individual may have a concern. Contacting the Privacy Administrator by calling (902) 423-6002 or emailing cathedralchurch@eastlink.ca can access this information.

9. Access

An individual has the right to access their personal information under the control of the Cathedral Church. Upon written request to the Privacy Administrator at the mail or emailing address listed below, the individual will be informed of the existence, use, and disclosure of their personal information and will be given access to the information. In certain exceptional situations, the Cathedral Church may not be able to provide access to certain personal information that it holds about an individual. For example, the Cathedral Church may not provide access to personal information if doing so would reveal personal information about a third party. If access cannot be provided, the Cathedral Church of All Saints will notify the individual, in writing or by phone call, of the reasons for refusal.

10. Handling enquiries and complaints

11. Revisions to this policy
